ORDINANCE NO. ORD-2012-9339

AN ORDINANCE CANVASSING THE RETURNS AND DECLARING THE RESULTS OF THE GENERAL MUNICIPAL ELECTION HELD ON MAY 12, 2012; FOR THE PURPOSE OF ELECTING CITY COUNCIL PLACES FOUR (4), SIX (6), AND EIGHT (8) FOR A TERM OF THREE (3) YEARS.

WHEREAS, the City of Irving, Texas, held a general municipal election on the 12th day of May, 2012 for the purpose of electing City Council Places four (4), six (6), and eight (8) for a term of three (3) years; and

WHEREAS, public notice of such general municipal election was duly given, and such election was duly and properly held and administered in accordance with the laws of the State of Texas, the Charter of the City of Irving, and the Federal Voting Rights Act of 1965; and

WHEREAS, a canvass of the general municipal election returns was conducted on May 23, 2012; and

NOW, THEREFORE, BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF IRVING, TEXAS:

SECTION 1. That the general municipal election held on May 12, 2012, was duly and legally called and notice thereof given in accordance with the laws of the State of Texas, the Charter of the City of Irving, and the Federal Voting Rights Act of 1965 and the ordinance calling said election; that said election was held in strict conformity with the Constitution and laws of the State of Texas, the Charter of the City of Irving, and the Federal Voting Rights Act of 1965, and the returns thereof have been properly made to the officials of the City of Irving entitled to receive the same, and that said election properly represents the desires of the voters of the City of Irving.

SECTION 2. That the following named candidate was duly elected at said general municipal election to the respective named office of the City of Irving:

Brad LaMorgese - Council Member Place 6, District 6 - Single Member

Tom Spink - Council Member Place 8, At-Large

SECTION 3. That a runoff election will be held on June 23, 2012, between Phil Riddle and Joe Putnam to determine who will be elected as Council Member Place 4, District 4- Single Member.

SECTION 4. It is hereby declared that the City of Irving approves and accepts the results of the general municipal election for Council Members, Place 4, Place 6 and Place 8, as set forth in the Election Returns Sheet attached as determined by the majority vote of the qualified voters of the City of Irving, Texas.

SECTION 5. Should any court of competent jurisdiction declare any section, subsection, clause, or phrase of this ordinance unconstitutional or invalid, it is expressly provided that any and all remaining portions of this ordinance shall remain in full force and effect. The City Council hereby declares that is would have passed this ordinance, and each section, subsection, clause and phrase, without the inclusion or any unconstitutional or invalid provisions.

SECTION 6. It is officially found, determined, and declared that the meeting at which this ordinance is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting was given.

SECTION 7. This ordinance shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.
